ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF CREATIVE ENTERPRISES, INC.

Pursuant to the provision of Idaho Code Section 30-1-59, et. seq., the undersigned corporation adopts the following Articles of Amendment to its existing Articles of Incorporation:

The following sections of the previously filed Articles of Incorporation shall be modified as follows:

Article IV., Section 2. Number of Shares. The aggregate number of shares which this corporation shall have authority to issue is One Hundred (100) shares with no par value.

A. Article IV., Section 2. Number of Shares shall be changed to read as follows:

The aggregate number of shares which this corporation shall have authority to issue is One Million (1,000,000) with no par value.

All other provisions of the original Articles of Incorporation shall remain the same.

The date of adoption of this amendment is January 19, 1990.

The number of shares entitled to vote on this amendment is 100 shares. The number of shares who voted in favor of this amendment was 100 shares. The number of shares who voted against
