ARTICLES OF INCORPORATION
OF
KRAHN'S HOME FURNISHINGS, INC.

The undersigned, acting as the sole incorporator of a corporation organized under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is KRAHN'S HOME FURNISHINGS, INC.

ARTICLE II.

The corporation shall have perpetual existence.

ARTICLE III.

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of common stock with a part value of \$1.00 each.


