

ARTICLES OF INCORPORATION  
OF  
PIRANHA KNIFE COMPANY

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is PIRANHA KNIFE COMPANY.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is for the manufacturing, wholesale and retail sales of cutlery and other specialty products plus any other thing for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares, all of which are to be without par value.

FIFTH: The address of the initial registered office of the corporation is 4197 North 1380 East, Buhl, Idaho 83316, and the name of its initial registered agent at such address is Scot Horton.
