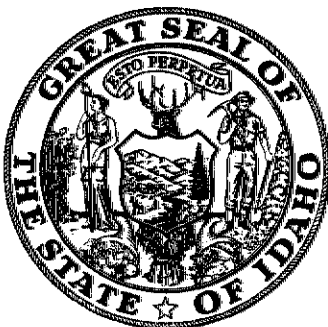

The undersigned persons acting as incorporators of a corporation under the provisions of the Idaho Business Corporation Act adopt the following Articles of Incorporation:

ARTICLE I






