Under the Idaho Business Corporation Act, and pursuant to the requested vote of its directors and shareholders at a regularly conducted meeting held on December 12, 2007, the following Amended and Restated Articles of Incorporation for such corporation were adopted:

**ARTICLE I**

The name of the corporation is McAlvain Services, Inc.

**ARTICLE II**

The period of its duration is perpetual.

**ARTICLE III**

The purpose, objectives and business of the Company shall be any lawful purpose.

**ARTICLE IV**

The aggregate number of shares which the corporation shall have authority to issue is 1,000 Shares of \$1.00 par value for an aggregate authorized capital of \$1,000.00. The stock shall not be certificated.

**ARTICLE V**




