- 3. The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Delaware.
- 4. The total number of shares of stock which the corporation shall have authority to issue is two thousand (2,000) and the par value of each of such shares is Ten Dollars (\$10.00) amounting in the aggregate to Twenty Thousand Dollars (\$20,000.00).


