

ARTICLES OF INCORPORATION
OF THE

MODERN WOODMEN and ROYAL NEIGHBORS BUILDING ASSOCIATION.

KNOW ALL MEN BY THESE PRESENTS:--

That we, the undersigned, all bona fide residents of the State of Idaho, have this day associated ourselves together for the purpose of forming a corporation under the laws of Idaho, and we hereby CERTIFY:--

FIRST:-- The name of the corporation shall be

"MODERN WOODMEN and ROYAL NEIGHBORS BUILDING ASSOCIATION."

SECOND:-- The purposes for which it is formed shall be to engage in the purchase of lots, construct buildings, engage in the renting thereof, buy and sell realty, sell, lease, acquire, make, construct, provide, maintain, equip, alter, erect, improve, repair, manage halls, dwellings, stores, hotels or other buildings, conveniences and properties of any description in connection with or which may seem to the Company conducive to the attainment of any of the objects of the Company.

To acquire by purchase or otherwise, property, real or personal, of any firm, person or corporation, including the capital stock thereof, and to pay for the same in cash, stock or other securities of the corporation.

To conduct its business in all its branches and without restriction to contract, buy, sell, lease, mortgage and convey such real and personal property as shall, from time to time be found necessary and convenient for the purposes of the Company's business.

THIRD:-- That the place where its principal business is to be transacted is at Kingston, Shoshone County, Idaho.

FOURTH:-- That the term for which it is to exist is ~~in~~ fifty years from and after the date of its incorporation.

FIFTH:-- That the number of trustees shall be seven and the names and residences of those who are appointed for the first year are:--

SIXTH:-- That the amount of the capital stock of said corporation is THREE THOUSAND DOLLARS and the number of shares into which it is divided is Three Thousand shares of the par value of ONE DOLLAR each.

EIGHTH:-- The Directors may meet for the transaction of business , at such times and places as may be provided by the By-laws of the Corporation.

The Board of Directors may by means of a resolution of the whole Board, at a meeting duly called for that purpose, designate three directors to constitute an executive Committee, which Committee shall have and may exercise all the powers and rights of the full Board of Directors in the management of the business affairs of the Company.
