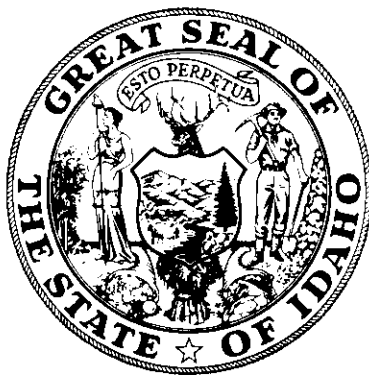

ARTICLES OF INCORPORATION
OF
MARK L. PETERSON, D.D.S.,
CHARTERED PROFESSIONAL ASSOCIATION

I, the undersigned, a natural person over the age of eighteen (18) years, who is a citizen of the United States of America, and a resident of the State of Idaho, and licensed to practice dentistry in the State of Idaho in order to form a corporation for the purposes hereafter stated, pursuant to the professional service corporation act of the State of Idaho, Idaho Code Title 30, Chapter 13, do hereby certify as follows:

ARTICLE I
NAME

The name of this corporation shall be MARK L. PETERSON, D.D.S.,
CHARTERED PROFESSIONAL ASSOCIATION.

ARTICLE II
DURATION

The Corporation is to have perpetual existence.

ARTICLE III
PURPOSES

The purpose or purposes for which the Corporation is formed are as follows: To engage in and carry on the practice of dentistry; to carry on such practice only through officers, employees, and agents who are duly licensed and authorized to render professional dentistry services through admission to practice by the Board of Dentistry; to own, hold title to, use, convey, mortgage, sale, pledge, and otherwise employ and invest in real estate, mortgages, stocks, bonds, or any other types of investments, in any and all types and kinds of personal property necessary for the rendering of dentistry services; to comply at all times with the provisions of Idaho Code Title 30, Chapter 13, as presently enacted or as may be hereafter amended or superceded by any other statute.

In general, to carry on any business with connection therewith and incidental thereto not forbidden by the laws of the State of Idaho and with all the powers conferred upon Corporations by the State of Idaho.

ARTICLE IV
AUTHORIZED CAPITAL STOCK

The aggregate number of shares which a corporation shall have authority to issue is Twenty-five Thousand (25,000) common shares, each having a par value of One Dollar (\$1.00) per share.

ARTICLE V
VOTING

Each shareholder of record shall have one (1) vote for each share of stock standing in his name on the books of the Corporation.

ARTICLE VI
OFFICE

The location of the first registered office is: 159 W. Main, Rigby, Idaho 83442. Mark L. Peterson is the initial registered agent at the above address.

ARTICLE VII
DIRECTORS

The initial director of the corporation shall be Mark L. Peterson, whose address is: 159 W. Main, Rigby, Idaho 83442. Mark L. Peterson shall serve as director until the first annual meeting of shareholders or until his successor be elected and qualified.

ARTICLE VIII
INCORPORATORS

The name and place of residence of each incorporator and the number of shares subscribed by him are as follows:

MARK L. PETERSON, 159 W. MAIN, RIGBY, IDAHO - ONE (1) SHARE.

ARTICLE IX
CONDITION OF OWNERSHIP OF SHARES

(a) The Corporation shall not issue any stock to any person who is not duly licensed or otherwise legally authorized to render professional dentistry services in the State of Idaho.

(b) No shareholder of the Corporation shall enter into a Voting Trust Agreement or any other type of agreement vesting another person with authority to exercise the voting power of any and all of his stock unless such person is duly licensed and otherwise legally authorized to render professional dentistry services in the State of Idaho.

(c) If any officer, shareholder, agent, or employee of the Corporation who has been rendering professional service to the public becomes legally disqualified to render such professional services within this State, or is elected to a public office or accepts employment that, pursuant to existing law, places restriction or limitations upon his continued rendering of such professional services, he shall sever all employment with, and financial interest in this Corporation forthwith.

(d) No shareholder of this Corporation may sell or transfer his shares in said Corporation except to another individual who is eligible to practice dentistry in the State of Idaho, and such sale or transfer may be made only after the same has been approved, at a stockholders meeting especially called for such purpose, by such proportion, not less than a majority, of outstanding stock as may be provided in the By-Laws of the Corporation.

(e) No shareholder shall as such have an preemptive or other preferential right to subscribe for, purchase, or receive any shares of stock of the Corporation, which it may issue or sell, whether out of the

number of shares acquired by the Corporation after the issuance thereof, or shall any shareholder as such have an preemptive or other preferential right to subscribe for, purchase, or receive any bonds, debentures, or other obligations or securities which a corporation may issue or sell which are convertible into or exchangeable for, stock, or to which shall be attached or appertain any option or warrant or other instrument which shall confer upon the holders or owner of such obligation or security the right to subscribe for, purchase, or receive from the Corporation any shares of its capital stock.
