ARTICLES OF INCORPORATION FOR THE MOSCOW MEALS ON WHEELS

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being all of legal age, and citizens of the United States of America, have voluntarily associated ourselves and do upon the date of these presents hereby voluntarily associate ourselves together for the purpose of forming a corporation of benevolent character under Title 30 Chapter ll of the laws of the State of Idaho, and we do hereby adopt and certify the following Articles of Incorporation, to-wit:

#### Article I

NAME: The name of this corporation shall be the MOSCOW MEALS ON INC., WHEELS, whose members shall have equal rights and interests with no member having or equiring a greater interest herein than any other member.

#### Article II

In furtherance, and not in limitation of the general powers conferred by the Laws of the State of Idaho, this corporation shall have the following objects, purposes and powers with the specific and primary purpose for which it is formed being set forth in paragraphs below:

- (a) to sponsor, promote and operate the Meals On Wheels food service for the aged and handicapped.
- (b) This corporation shall be a non-profit corporation and pecuniary profit of the same is not the object of this corporation.
- (c) In the event of dissolution of this corporation, either voluntarily or by legal action, the assets of this corporation shall be transferred to another legal corporation having similar goals and purposes. In no event shall the assets of this corporation innure to the benefit of either the officers, or incorporators of this corporation.

# Article III

PLACE OF BUSINESS: The principal place of business of this organization shell be Moscow, Lateh County, State of Idaho.

### Article IV

TERM: The life of this corporation shall be perpetual.

#### Article V

This corporation is not organized for profit and shall have no capital stock, and shall be composed of members rather than share holders in accordance with the foregoing provisions.

#### Article VI

The conditions and regulations of membership and the rights and privileges of members shall be determined and fixed by the by-laws.

#### Article VII

The private property of the members shall not be subject to the payment of the corporate debts, liability or obligations to any extent what-soever.

### Article VIII

The number of directors of this corporation shall be not less than 5 nor more than 15 as set from time to time in the by-laws of the corporation. The directors qualifications and terms of office, manner of election (except the first Board of Directors which was elected as herein set forth), time, place and manner of calling meetings and other powers and duties of the directors shall be prescribed by the by-laws.

### Article IX

The officers of this corporation shall consist of a board chairman, vice-chairman, secretary, treasurer and/or program co-ordinator, officers as may be provided by the by-laws, and their qualifications, term of office, manner of election, time, place, and manner of calling meetings and other powers and duties shall be prescrived by the by-laws.

#### Article XI
