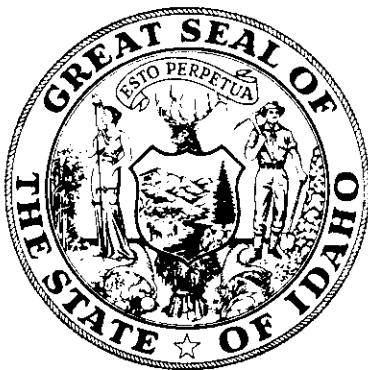

whose address is 721 Wyndemere, Boise ID 83702.


3. The corporation has no known actual or known potential creditors; and, therefore, the notice which otherwise is required by Section 30-1-87, Idaho Code, is not necessary.


