# ARTICLES OF INCORPORATION

OF

HIGHLAND FLATS LADIES' CLUB, INC.

KNOW ALL MEN BY THESE PRESENTS: That we whose names are hereto affixed, all of whom are bona fide residents and full age citizens of the United States of America, do under and in pursuance of I. C. 30-1001 et seq. of the Idaho Code as amended, and general corporation laws of the State, hereby organize, constitute and associate ourselves and such other persons as may hereafter become associated with us, in accordance with these Articles, into a body politic, and corporate for the purposes hereinafter set forth, and to that end we execute these Articles of Incorporation, and hereby certify, set forth and declare as follows:

I.

#### NAME

The name of the proposed corporation is HIGHLAND FLATS LADIES. CLUB, INCORPORATED.

II.

#### PURPOSES

The purposes of the corporation are as follows:

To be a benevolent corporation for the welfare of the general public.

To derive no profit of any kind from any real or personal property owned or being purchased or leased by this corporation, or from the use thereof.

To engage in the operation of any enterprises calculated or designed to provide for recreational, cultural and benevolent facilities for the general public so long as in conformance with the other purposes herein enumerated.

To generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform so long as in conformance with the other purposes herein enumerated.

To engage in the business of buying, acquiring, giving, owning, leasing, transferring, encumbering and generally dealing in real and personal property so long as in conformance with the other purposes herein enumerated.

To permit any person of the general public to make use of the property of the corporation for recreational, cultural and benevolent purposes in the manner prescribed by the corporation, reserving unto the corporation the right to determine what programs any property of the corporation shall be used for, and in general to have full control and authority of any and all sort over all the property of the corporation.

The purposes herein enumerated shall be construed both as purposes and powers and shall be in no wise limited or restricted by reference to, or inference from, the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation, nor shall the expression of one thing be deemed to exclude another, although it be of like nature unexpressed.

To do all and every thing necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized; and also so long as in conformance with the other purposes herein enumerated.

III.

The duration of the corporation is perpetual.

TV.

The location is in Highland Flats, Naples, Boundary County, Idaho; and the post office address of the registered office of the corporation in the State of Idaho is Naples, Idaho.

V.

Membership herein shall be evidenced by membership certificates. The cost of membership shall be as determined by the members at any regular membership meeting or special membership meeting called for that purpose. The rights and interests of all members shall be equal, and no member can have or acquire a greater interest therein than any other member.

### DIRECTORS

The corporate powers of this corporation shall be vested in a board of five (5) directors, to be elected as provided in the By-Laws of this corporation. To be a director a person must be a certificate holder. The powers and duties of the officers of this corporation shall be as prescribed in the By-Laws.
