The undersigned incorporators, desiring to form a corporation pursuant to the provision of the Idaho Business Corporation Act, adopt the following Articles of Incorporation.

T

The name of the corporation is RECORDAFAX, INC.

ΙI

The purposes of the corporation are:

- (a) To purchase, sell and trade in dental patient information and records systems.
- (b) To purchase or otherwise acquire, own, mortgage, pledge, sell, manufacture, assign and transfer or otherwise dispose of, to invest, trade, deal in and deal with goods, wares and merchandise and real and personal property of every class and description and to generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform.
- (c) To engage in any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

III

The duration of the corporation is perpetual.

ΙV

The address of the corporation's initial registered

office is 1541 East Clark, City of Pocatello, County of Bannock, State of Idaho, 83201, or at such other place as the Board shall designate, and Larry J. Kemp of 1541 East Clark, Pocatello, Idaho 83201, is the initial registered agent of the corporation.

The aggregate shares which the corporation shall have authority to issue is 50,000 shares of common stock at no par value.

Each outstanding share of stock shall be entitled to one vote on each matter submitted to a vote at a meeting of shareholders.
