ARTICLES OF INCORPORATION OF WOOD RIVER WELDING COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, each and all being natural persons of full age and citizens of the United States have this day and do hereby voluntarily associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and we do hereby certify:

-1-

The name of said corporation shall be Wood River Welding Company, Inc.

-2-

The location and post office address of the registered office of the corporation is P.20. Box 72, Bellevue, Idaho, 83313.

-3 -

The corporation is to have perpetual existence.

-4-

The total amount of authorized capital stock is 1,000 shares of the par value of \$100.00 per share with an aggregate value of \$100,000.00. All such stock shall be common and non-assessable and each and every share issued shall have the same rights and voting powers.

-5-

The business of this corporation shall be managed by a board of at least five directors who need not be shareholders, provided, however, that any greater number of directors may be provided for by the By-laws of said corporation.

The purposes for which said corporation is formed are as follows:

- (a) To engage in all manners of welding, blacksmithing, repairing and the custom building and fabrication of machinery, component parts thereof and equipments of all sorts and kinds.
- (b) To manufacture, purchase, repair, and sell plows, cultivators, and other farming and agricultural implements of all kinds, to purchase and sell all materials necessary or convenient in the prosecution of said business, and to take, own, hold, mortgage, lease, and convey any and all real estate necessary or useful therein.
- (c) To manufacture machinery, tools, parts of machinery, and similar articles of commerce from iron, steel, other metals, wood, and similar materials, and construct, weld, repair, and erect the same; to conduct, manage, and control the business of making and selling small tools, and special parts for machinery, and to engage in the general machinery manufacturing business and to do everything necessary to carry on the general machinery and sales business.
- (d) To buy, sell, distribute, import, export, manufacture, service, and otherwise deal in iron and steel products and their alloys, nonferrous products and their alloys, wood products, and plastics.
- (e) To buy and sell, export, import, lease, exchange, and generally deal in machinery and equipment of all kinds and descriptions and to act as agent for others for all or any of said purposes.
- (f) To purchase, improve, develop, lease, exchange, sell, dispose of, and otherwise deal in and turn to account, real estate; to purchase, lease, build, construct, erect, occupy, and manage buildings of every kind and character whatsoever; to finance the purchase, improvement, development, and construction of land and buildings belonging to or to be acquired by this company, or any other person, firm or corporation.
- (g) To engage in the rental, loan, and lease of automobiles, trucks, tractors, trailers, machinery and equipment and, without limitation, all types of motor vehicles, and, in connection therewith, to purchase and sell motor vehicles and equipment, vehicle parts, articles, and accessories, and to perform repairs and services in connection with the leasing, loaning, or rental of such vehicles, and to acquire, hold, and own any and all licenses, permits and franchises necessary or useful in connection with the business.

- (h) To buy, acquire, own, trade, pledge, and sell capital stock, bonds, debentures or other securities issued by any other corporation, private, public or municipal or by any state or political Subdivision of the United States.
- (i) To purchase and acquire its own stock, as well as the stock in any other corporation whose stock is owned by the same or largely the same stockholders; and do all manner of lawful business with other corporations, including corporations whose stock is owned by the same or largely the same stockholders.
