ARTICLE 1: The name of the corporation shall be SAVE TETON ROADS INC.

ARTICLE 2: The purpose for which the corporation is organized is: To improve streets and roads within Teton County Idaho. Such streets and roads include those which are within city limits of municipalities, those in unincorporated areas of the county and those which are in private ownership as opposed to public ownership.
