IDIANO SECRETARY OF STATE

The undersigned, acting as the Incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Theorporation for such corporation:

I.

The name of the corporation is The ReSource Trust, Inc.

II.

The corporation is organized exclusively for charitable, religious, literary, scientific and educational purposes as set forth in Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code (the "Code"), including, but not limited to the operation of a private foundation for making grants and other qualifying distributions for deductible purposes within the scope of Sections 170(c)(1) and 170(c)(2)(B).

III.

The number of directors constituting the initial Board of Directors of the corporation is not less than three (3). A change in the number of directors may be made by amending the Bylaws of the corporation.

IV.

The street address of the initial registered office of the corporation is 323 Lewis Street, Suite A, Ketchum, Idaho, and the name of its initial registered agent at such addresses is William A. McMahan.

ARTICLES OF INCORPORATION - 1

VI.

The corporation shall have no members.

VII.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

VIII.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above.

IX.

The corporation shall not attempt to influence legislation, by propaganda or otherwise, and the corporation shall not participate in, or intervene in (including the publishing of distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Code.

The Corporation shall distribute its income for each

tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code. Further, the Corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code, nor retain any excess business holdings as defined in Section 4943(c) of the Code, nor make any taxable expenditures as defined in Sections 4944 or 4945(d) of the Code.

IX.

The corporation shall have all of the powers granted nonprofit corporations under the laws of the State of Idaho. However, notwithstanding anything herein to the contrary, the corporation shall exercise only such powers as are in furtherance of the tax exempt purposes of organizations set forth in Section 501(c)(3), of the Code.
