Pursuant to the provision of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: That Article V of the Articles of Incorporation providing for seven (7) Directors is hereby amended to permit nine (9) Directors.

That the number of shares voted in favor of such amendment was 151 and that the number of shares voted against such amendment was zero. The total number of shares entitled to vote on this matter is 214.




