The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is SAWTOOTH WESTERN AREA ADVERTISING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the Corporation is organized are: To engage in the advertising of Big O Tires and products and related activities and any and all lawful business for which corporations may be incorporated under the Idaho Business Act.

The aggregate number of shares which the FOURTH: Corporation shall have authority to issue is 100 with a par value of \$1.00.

The transfer and hypothication of the shares FIFTH: of the Corporation are restricted and such restriction is specified in the By-Laws of the Corporation and on the stock certificates. Shares in the Corporation may only be owned by Big O Tires, Inc., franchise owners.

The holders of shares of stock in this SIXTH: Corporation are not entitled to pre-emptive rights to purchase additional shares of stock.

SEVENTH: The address of the initial registered office of the Corporation is 216 E. Fairview, Meridian, Idaho 83642, and the name of its initial registered agent at such address is Kenneth A. Roetto.

EIGHTH: The number of directors constituting the initial Board of Directors of the Corporation is eight (8), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
