KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are citizens and residents of the STATE OF IDAHO, have today voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

That the name of said corporation is SHAMROCK INC.

That the purposes for which this corporation is formed are:

- (a) A general investment and real estate business;
- (b) To take, acquire, buy, hold, own, maintain, develop, convey, lease, mortgage, exchange, improve and deal in real estate and real property, buildings, or any interest or rights in any real estate, buildings, any real property, improved, or unimproved;
- (c) To borrow or lend money, with or without security, and to purchase, produce, manufacture, hold, sell, exchange, and otherwise acquire, deal in, and dispose of personal property, goods, wares and merchandise, chattels and choses in action of every kind and nature, and stocks, bonds, mortgages, notes, bills of exchange, securities and obligations of every kind and nature, including the capital stock, bonds and securities of this corporation and other corporations;
- (d) To erect, construct, alter, improve and maintain houses, business buildings and improvements to real property of every description;
- (e) To buy, sell, manufacture, deal in and deal with goods, wares and merchandise of every kind and nature, to carry on such business as wholesalers, importers and exporters and retailers.
- (f) To have the powers and do those acts, things and deeds as set forth in Section 30-114 of the Idaho Code and any and all Amendments thereto;

(g) To do all acts and things necessary to carry out the purposes and intents expressed in the above provisions.

That the location and post office address of the registered office of this corporation is Pocatello, Bannock County, Idaho.

IV

That the capital stock of the corporation shall be \$100,000.00, and shall be divided into 1000 shares of the par value of \$100.00 each.

That the common stock shall be entitled to one vote in the affairs and proceedings of the corporation for each share of stock outstanding and fully paid. The stock shall be non-assessable.

That the number of the members of the Board of Directors of said corporation shall be three, all of whom shall be shareholders in said corporation. The Directors shall also have the power, without the assent or vote of the stockholders to make or alter the By-Laws of said corporation, fix the time for payment of dividends, fix and vary the amount to be reserved as working capital; to borrow money, and authorize and cause to be executed mortgages and loans upon all of the property of the corporation, or any part thereof; and to fix the salary and compensation for services to be paid to all officers and employees of the corporation. The Board of Directors shall also have such powers as are conferred upon a Board of Directors of a corporation under the laws of the State of Idaho.
