1 Articles of Incorporation of the
2
3 Belleme Water Company
4

5 Know all men by these Presents:
6 That we the undersigned have this day
7 associated ourselves together for the purpose
8 of incorporating under the laws of the
9 laws of the Territory of Idaho, a corporation
10 to be known by the corporate name of
11 "The Belleme Water Company"
12

13 And we hereby certify that the objects
14 for which this Corporation is formed are;
15 to construct water works for the purpose
16 of piping water into and throughout the
17 City of Belleme and to conduct the business
18 of furnishing and supplying said City and
19 the citizens thereof with water, also to accept
20 and to fulfill the terms of the franchise
21 heretofore granted to H. E. Miller S. B. Dilley
22 J. A. Luck and others, by an ordinance of
23 the City of Belleme Passed March 8th 1887
24 and approved March 10th 1887

25 That its principal place of business
26 shall be in the City of Belleme Alturas
27 County Idaho Territory

28 That the term of its existence shall be
29 forty nine years from and after the date
30 of its incorporation

31 That the number of its directors shall be
32 seven; and that the names of those who

shall be directors and serve as such officers
the first year and until the election and
qualification of their successors are
