# ARTICLES OF INCORPORATION FOR MIXITRON CORPORATION

SECRETARY OF STATE  
STATE OF IDAHO

1. The name of the corporation shall be **MIXITRON CORPORATION**.
2. The corporation's period of duration shall be perpetual.
3. The purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be organized under the IDAHO BUSINESS CORPORATION ACT.
4. The aggregate number of shares which the corporation shall have authority to issue shall be 1,000,000. These shares shall be divided into two classes, Class A stock and Class B stock. There shall be 500,000 shares of Class A, nonvoting stock, and 500,000 shares of Class B, voting stock. Class A shares shall be without par value. Class B shares shall be without par value.
5. The Board of Directors may establish special series of stock according to necessity from time to time.
6. These ARTICLES OF INCORPORATION adopt by incorporation the PRELIMINARY AGREEMENT heretofore signed between the original stockholders as beginning BYLAWS of the corporation.
