ARTICLES OF INCORPORATION

OF MAR ZA TREASURE VALLEY LEATHER SLAPPERS RIDING CLUB, INCS PH 35 OF IDAHO

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of corporation is Treasure Valley Leather Slappers

Riding Club, Inc. of Idaho.

SECOND:

The corporation is a nonprofit corporation organized under

Idaho Code 30-301 et seq.

THIRD:

The period of the corporation's duration is perpetual.

FOURTH: The purpose for which the corporation is organized is as follows: Nonprofit Horse Riding Club Organization.

FIFTH; There shall be no capital stock in the corporation. There shall be one class of members in the corporation; the designation of the membership class, manner of qualifying for membership and rights of membership in the corporation shall be set forth in the Bylaws of the corporation.

SIXTH: Notwithstanding any other provision of these Articles of Incorporation; the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt form Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954, as now in force or as may afterwards be amended. This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

SEVENTH: In no event shall any income or assets of this corporation be distributed to or inure to the benefit of any member, director, or officer of this corporation, either directly or indirectly, other than as bona fide expenses in carrying out the directions and authorities of the Board of Directors and Officers hereof in carrying out the purposes of the corporation.
