# ARTICLES OF INCORPORATION 9 RPR 20 RM 9 01

The undersigned, being the incorporator of a corporation organized under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I.

The name of the corporation is BLUE LAKE PROPERTY OWNERS' ASSOCIATION, INC.

ARTICLE II.

The corporation is a nonprofit corporation.

ARTICLE III.

The corporation shall have perpetual existence.

ARTICLE IV .- VI.

The purpose or purposes for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

#### ARTICLE VII.

The corporation shall provide for an annual meeting of its members to elect a 5-member Board of Directors who shall have authority to act on behalf of the membership in the regulation of the internal affairs of the corporation.

#### ARTICLE VIII.
