I

That the name of said Corporation should be the BUHL RIFLE AND PISTOL CLUB, INC.

II

The purpose for which it is formed is to promote the social welfare of the members of the Buhl Rifle and Pistol Club, Inc., and to give them a common place for entertainment and recreation; also the encouragement of organized rifle and pistol shooting among citizens of the United States resident in our community.

III

To enjoy all the benefits and privileges incident to and permitted under the laws of the State of Idaho relative to corporations of this character, and so that the purpose specified in Article II hereof may be carried into effect, said Corporation is empowered to receive, own, buy, lease, hold, convey, dispose of, and mortgage such real estate and personal property as may be deemed necessary for the complete exercise and enjoyment of said privileges and purpose, and to sue and be sued in its corporate name.

IV

The officers of the Corporation shall be President, Vice-President, Secretary, Treasurer, Chief Instructor, and Executive Officer. The offices of Secretary and Treasurer can be combined into a single office. Such officers shall be elected and qualify for one year or until their successors are elected and qualified. The above named officers in Section IV shall  
Constitute the Executive Committee, and shall have the power to enact in the name of the Corporation, as set forth in the by-laws of the Corporation. The election of above named

officers shall be set forth in the by-laws of the Corporation, and are hereby named as follows: also they shall hold office until the third Tuesday of September, or until there successors are duly elected and qualified.

#### V

Membership in said Corporation shall be open to citizens of the United States, having been approved by the Executive Committee and subscribing to the Oath of Allegiance as set forth in Article III of the Corporation by-laws. The membership dues are payable as set forth in Article IV of the Corporation by-laws.

#### VI

The location shall be 1230 E. 4100 N. in the City of Buhl, County of Twin Falls, State of Idaho. The mailing address shall be that of the club Secretary.

#### VII

The association shall have no capital stock. The right and interests of all members shall be equal.

#### VIII

The term for which this Corporation shall exist shall be PERPETUAL. This Corporation shall remain in existence until it is terminated.

#### IX

The by-laws of said Corporation may be amended, changed or modified at any regular meeting of the membership of said Corporation, or at any special meeting called for that purpose.

#### X

These Articles may be amended by a two-thirds vote of the Executive Committee of the Corporation at any Executive Committee meeting or at any special meeting called

for that purpose. The regular annual meeting shall be the third Tuesday of September of each year. That special meeting may be called under provisions set forth in Article V of the Corporation by-laws.
