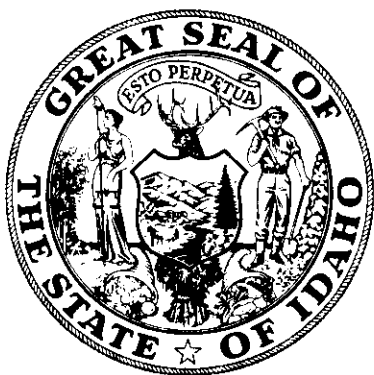

ARTICLES OF AMENDMENT  
to the  
ARTICLES OF INCORPORATION  
of  
INTERNATIONAL MUTUAL ASSISTANCE ASSOCIATION OF IDAHO, INC.

Pursuant to the provisions of Section 30-327 of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is International Mutual Assistance Association of Idaho, Inc.

SECOND: The following amendment is an addition to the original articles of incorporation. The new article shall be designated Roman numeral X and shall read:

"Pursuant to section 30-314(f) of the Idaho Code, the existing directors shall elect the successor directors."

THIRD: The preceeding amendment was adopted by the board of directors because as yet there are no members of the corporation.

FOURTH: A meeting was held on July 1, 1986 at which all the directors were present. All the directors voted in favor of the amendment.
