WHEREUPON, Bill Ballantyne, acting Chairman of the Board of Directors of Caldwell Elks Home Association announced that the only order of business was the consideration of a motion made on the 11th day of May, 1972, to amend the Articles of Incorporation of the Caldwell Elks Home Association, more particularly paragraph Fourth thereof, which reads as follows:

That the term for which said corporation is to exist is fifty (50) years from and after the date of its incorporation."
