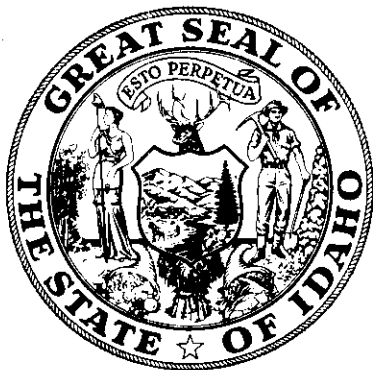

ARTICLE I

The name of this organization, as incorporated under the laws of the State of Idaho, shall be Calvary Free Will Baptist Church.

ARTICLE II

Calvary Free Will Baptist Church is a non-profit corporation. All money received and used for operating expenses will be derived from tithes and offerings of its members and friends.

ARTICLE III

It is our desire and intent for this religious, non-profit corporation to continue without end.

ARTICLE IV

ARTICLE V
