

The undersigned, a natural person over the age of twentyone years, acting as the incorporator of a corporation under
the Misconsin Business Corporation Law (Chapter 180 of the
Misconsin Statutes), adopts the following Articles of Incorporation for such corporation:

Find: The name of the corporation is NEENAH PAPER COLFAIR, INC.

SECOND: The purposes for which the corporation is organized are to manufacture and sell paper, paper stock and paper products, and to engage in any lawful activity within the purposes for which corporations may be organized under the wisconsin susiness Corporation Law, Chapter 180 of the Wisconsin Statutes.

Iniad: The aggregate number of shares which the corporation shall have authority to issue is five thousand, consisting of one class only, designated as "Common Stock", of the par value of 55 per share.
