## ARTICLES OF INCORPORATION

OF

NORTH IDAHO TELEVISION, INC.

We, the undersigned, incorporators for the purpose of forming a corporation under and pursuant to Title 30, Chapter 1 of the Idaho Code do hereby certify the following:

Ι

The name of this corporation shall be:

NORTH IDAHO TELEVISION, INC.

ΙI

The duration of this corporation shall be perpetual.

III

The corporation is being formed for the purpose of engaging in the business of television broadcasting on an assigned channel and to carry on all other businesses incident thereto or connected therewith; and to broadcast, disseminate, distribute, transmit, retransmit, receive, or collect by electronic, electrical, or other means, music, entertainment, news, speeches, sermons, advertising, educational and informative matter, photographs, pictures, scenes, or plays, or any other thing which may be transmitted by television or electronic signals. It shall have unlimited power to engage in, and to do any lawful act concerning any and all lawful business for which corporations may be organized under the Idaho Code.

IV

The location and post office address of the registered office of this corporation in the State of Idaho shall be 1375 West Honeysuckle, Coeur d'Alene, Idaho 83814, and its registered agent at that address is Thomas Daugherty.

The aggregate number of shares which this corporation shall have authority to issue is 2500 shares, with a par value of \$100.00 per share, having an aggregate par value of \$250,000 which shall be known as common stock. This stock, to the extent possible, shall be issued pursuant to the provisions of Sec. 1244 of the Internal Revenue Code.

All or any portion of these Articles of Incorporation may be amended by the affirmative vote of the holders of a majority of the stock entitled to vote.

IX

The management of this corporation shall be vested in a Board of Directors consisting of not less than one or more than five Directors to be elected at the annual meeting of this corporation.

The officers of this corporation shall consist of a President, Vice-President, Secretary and Treasurer, and any two of the offices, except those of President and Secretary, may be held by the same person.
