The following Articles of Incorporation are hereby adopted pursuant to the Idaho Business Corporation Act:

1. Name.

The name of the corporation is:

2. Duration.

The corporation shall have perpetual duration.

3. Purposes.

The corporation is formed for the purposes of dealing in potatoes and agricultural products of all kinds, and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

The corporation shall be authorized to issue 500,000 shares, all of one class, for a par value of \$1.00 per share.


