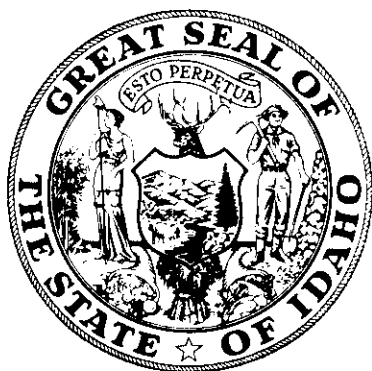

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Nugget Enterprises, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the operation, management and publication of newspapers and the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000, all of one class, \$1.00 par value.

FIFTH: The address of the initial registered office of the corporation is, Marsing, Idaho and the name of its initial registered agent at such address is Micky Dean Hodges. PO Box 426






