

ARTICLES OF INCORPORATION

FOR

I.

The name of this corporation is **CALVARY CHAPEL OF GARDEN VALLEY, INC.**

II.

This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law primarily for religious purposes.

III.

The name and address in the State of Idaho of this corporation's registered agent for service of process is: **TREVOR ADAMS**, who's physical address is **20 Trinity Lane, GARDEN VALLEY, IDAHO 83622**.

IV.

A. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code, (b) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements on behalf of any candidate for public office.

E. The duration of the corporation will be for 97 years.


F. The incorporator is Trevor Adams.

H. This corporation has no members.


V.


