- BLOCK 2: To change the registered agent or office, strike the incorrect information and write in the correct information. Note: The office of the registered agent must be at a street address in Idaho; not a Post Office Box or Personal Mail Box.
- BLOCK 3: Only a new registered agent must sign in Block 2.
- BLOCK 4: Enter names and business addresses of president, secretary and directors (for corporations only) or managers/members (for LLC's only). Note: Putting "same as last year" or "same as above" will not be accepted. Changes here will not affect
- BLOCK 5: May not be altered through the use of this form.
- BLOCK 6: The annual report must be signed by a person authorized to represent the corporation/LLC. Print or type the name and title of
