**ARTICLES OF INCORPORATION**

**FOR**

**ACCLAIM!, INC.**

**WE, THE UNDERSIGNED**, natural persons of the age of twenty-one (21) years or more, acting as incorporators of a corporation under the laws of the state of IDAHO, adopt the following **ARTICLES OF INCORPORATION** for such corporation.

**ARTICLE 1  
NAME**

The name of the corporation is **ACCLAIM!, INC.**

**ARTICLE 2  
DURATION**

The period of the corporation is perpetual.

**ARTICLE 3  
PURPOSES**

The purpose or purposes for which the corporation is organized are; electronic filing of medical claims, billing, and management services, and all business and performance of these services as necessary. And all other related acts authorized by law.

And, also to engage in any enterprise calculated or designed to be profitable to this corporation and in conformity with the laws of the states in which business is transacted.
