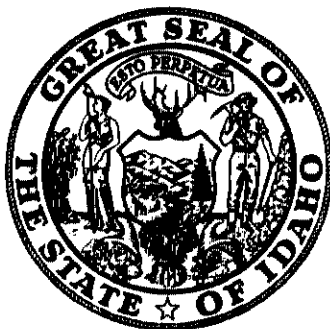
### CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation.

FIRST: The name of the corporation is Woolston Construction Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregated number of shares which the corporation shall have authority to issue is 1,000 shares of common capital stock with a par value of (\$1.00) per share.




