The undersigned, who are natural persons of full age and citizens and residents of the State of Idaho and the United States of America, for the purpose of forming a corporation under the laws of the State of Idaho, hereby certify and declare:

ARTICLE I.

The name of this corporation shall be TELSAT SYSTEMS, Inc.

ARTICLE II.

The period of duration shall be perpetual.

ARTICLE III.

The corporation is formed for the purpose of providing community antenna television services, unregulated sales of telecommunication equipment and services and for any and all lawful business for which corporations may be incorporated.

ARTICLE IV.

The corporation shall be authorized to issue no more than 2500 shares of common stock having no par value. All with equal rights, preferences, and voting rights.

ARTICLE V.

The initial registered office shall be P. O. Box 98, Albion, Idaho 83311.

ARTICLE VI.
