## CERTIFICATE OF REDUCTION OF PREFERRED STOCK OF A. P. GREEN REFRACTORIES CO. A MISSOURI CORPORATION

WM. S. LOWE, President of A. P. GREEN REFRACTORIES CO., a
Missouri corporation, files this certificate pursuant to the
provisions of Section 351.200 of The General and Business Corporation Law of Missouri and does certify as follows:

- 1. That said corporation, being duly authorized by its Articles of Incorporation, heretofore purchased out of surplus 240 shares of its authorized and issued 5% Cumulative Preferred Stock, having a par value of \$100.00 per share; that pursuant to the provisions of the Articles of Incorporation of said corporation and pursuant to resolution of its Board of Directors said shares so purchased were cancelled and retired.
- 2. The Articles of Incorporation of said corporation prohibit the reissue of the shares so purchased, cancelled and retired; therefore, the authorized 5% Cumulative \$100.00 par value preferred Stock of said corporation shall, upon the filing of this certificate, be reduced from 46,680 shares to 46,440 shares.
