THE COMMUNITY UNITED PRESBYTERIAN CHURCH OF KAMIAH, IDAHO, INC.

was filed in the office of the Secretary of State on the **first** day of **May,** A. D. One Thousand Nine Hundred **Fifty-Nine,** and is duly recorded on Film No. **106** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Kamiah,** in the County of **Lewis,** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

OF

THE COMMUNITY UNITED PRESBYTERIAN CHURCH OF KAMIAH, IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, members of The Community United Presbyterian Church of Kamiah, Idaho, all being natural citizens of the United States of America, of legal age, and residents and citizens of the State of Idaho, pursuant to the expressed desires and directions of the membership of said organization, do hereby, under and by virtue of the laws of the State of Idaho, and particularly of the provisions of Title Thirty, Chapter Eleven, of the Idaho Code, associate ourselves together and form a corporation, and for that purpose do certify as follows:

I.

That the name of this corporation is:

THE COMMUNITY UNITED PRESBYTERIAN CHURCH OF KAMIAH, IDAHO, INC.

II.

That this corporation is created for the accomplishment of religious, social and benevolent purposes, and shall have and exercise in the accomplishment of such purposes, the following particular powers and authority, to wit:

A. To establish and maintain a place or places and facilities for use as a place of public worship, in the Village of Kamiah, Lewis County, Idaho, and in such other places as its board of directors may determine as proper.

B. To establish and maintain places and facilities for religious instruction, and to further other religious and charitable work, and to provide for the social welfare of its members and the community in which such facilities are situated.

C. To acquire by purchase, gift or otherwise, and to own, hold, manage, lease, encumber, sell or convey, or hold in trust, real and personal property; to erect such buildings and memorials and other structures as may be necessary for the fulfillment of the purposes and objects of the corporation; to borrow money and secure the repayment of the same by pledges, mortgages, or the issuance of bonds or debentures, obligating the whole or any part of its property; to receive and accept donations of real or personal property by gift, grant, devise, or bequests.

D. To do any and all other things which may be requested, necessary or proper, in the accomplishment of the purposes and objects for which the corporation is formed.

III.

This corporation shall have perpetual existence and succession by its corporate name.

IV.

The location and post office address of the corporation's registered office in the State of Idaho shall be Kamiah, Idaho.

V.

This corporation shall have no capital stock, and shall not engage in business for profit, but shall be supported by gifts, bequests, contributions, benefits, and dues paid by its members. No part of the receipts or income of the corporation shall ever inure to the benefit of or be distributed to any individual member, members, or officers of the corporation.

VI.

The corporation shall support the doctrine and tenets, and be subject to, the laws, usages and customs of the United Presbyterian Church in the United States of America, as may from time to time be established, made and declared by the lawful authority of said church.

VII.

This corporation shall have a board of directors who shall also act as its board of trustees, which boards shall have the management and control of the real property of the corporation, as well as the control of the promotion, operation and maintenance of the corporation. The Board of Directors shall be elected and organized in accordance with the customs, laws and usage of the United Presbyterian Church in the U.S.A.

VIII.

Those becoming members of the Community United Presbyterian Church of Kamiah, Idaho, shall thereby be entitled to membership in this corporation.

IX.

The officers of the corporation shall consist of a president, and a secretary, and such other officers as may be provided for by usage and custom, or of the lawful regulations of the United Presbyterian Church in the U.S.A., from which also shall be determined the term of service and extent of the duties of such officers, and the manner and time of their election.

X.

The names and addresses of those elected as incorporator directors and trustees of the corporation for the year 1959 and until the election and qualification of their successors, are as follows:

That the directors hereinbefore names were chosen at an election held at the corporation's Church building in the City of Kamiah, Idaho, at eight p.m. on the 15 day of April, 1959, pursuant to legal notice thereof duly given; that a majority of the members of the organization present voted at such election, with the result that the directors and trustees hereinbefore named were unanimously elected for the year 1959.

That the following notice of said meeting, at which the directors and trustees were elected, was published in The Clearwater Progress, a weekly newspaper, printed and published at Kamiah, Lewis County, Idaho, that newspaper having been published in said county for more than 78 weeks next prior to the date of the election, and said notice appearing therein as follows, to wit:

"NOTICE OF MEETING"

NOTICE IS HEREBY GIVEN, that the members of the Community United Presbyterian Church of Kamiah, Idaho, will hold a meeting of its members, at 8 p.m. on the 15 day of April, 1959, in the church building in Kamiah, Idaho, for the purpose of electing five of its members as a board of directors, who will also act as its board of trustees, for the purpose of adopting articles of incorporation for said church, and such other business as may come before the meeting

That said notice was published for two weeks as required by law, appearing in the issues of March 26, 1959 and April 2, 1959, and a copy of said notice was posted in a conspicuous place on the building where such meeting and election was held, for a period of two weeks, and during the period of publication of said notice, prior to the date of the meeting and election, and due and legal Proof of Publication and posting duly made.

That the persons hereinbefore named were duly elected directors, as aforesaid; that Elmer E. Rosenkilde and Westley Pratt were the presiding chairman and secretary, respectively, of said meeting, and were the officers conducting the said election.


