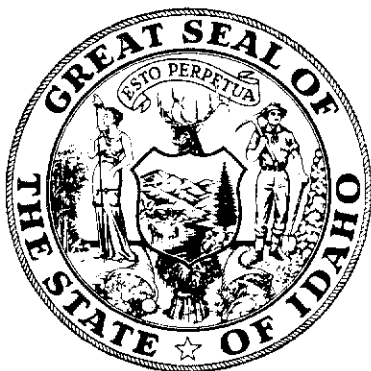

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the corporation is KDS, INC.

SECOND: The following amendments to the Articles of Incorporation were adopted by the sole shareholder of the corporation on January 5, 1987, in the manner prescribed by the Idaho Business Corporation Act:

"FIRST

"The name of the corporation is CENTENNIAL
DISTRIBUTING CO."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 500; and the number of shares entitled to vote thereon was 500.
