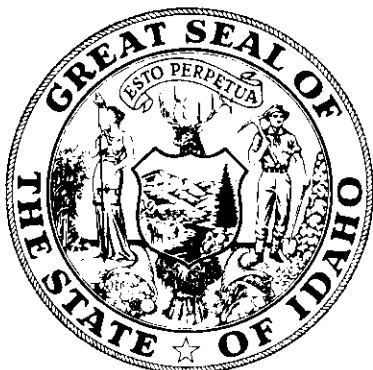

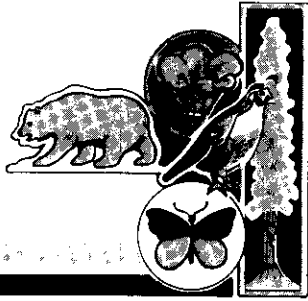

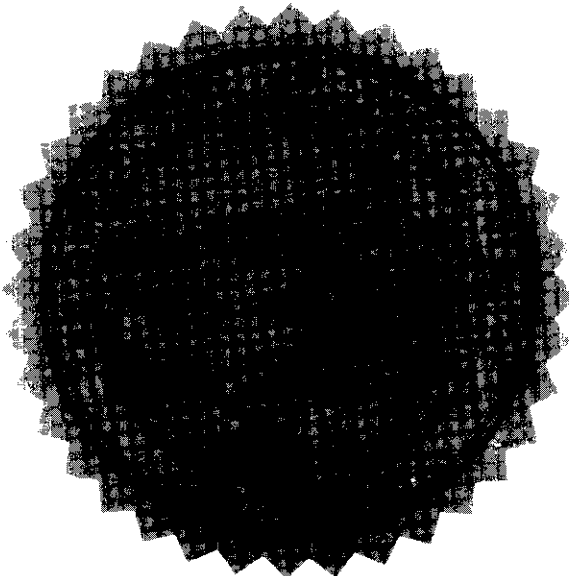

ARTICLE ONE: The name of this Corporation shall be:

ARTICLE TWO: All of the issued shares of capital stock of the corporation of all classes shall be held of record by not more than ten persons. This Corporation is a close Corporation.

ARTICLE THREE: The purpose of this Corporation is to engage in any lawful act or activity for which a Corporation may be organized under the General Corporation Law of California; other than the banking business, the trust company business, or the practice of a profession permitted to be incorporated by the California Corporations Code.

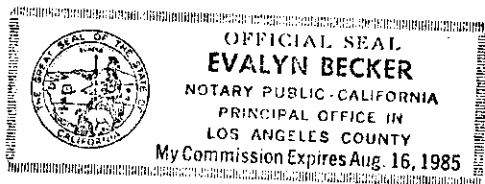
