I, **IRA H. MASTERS**, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

was filed in the office of the Secretary of State on the **FOURTH** day of **SEPTEMBER** A. D. One Thousand Nine Hundred Thirty-**SEVEN** and duly recorded in Book A-**81** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 29-103, Idaho Code, Annotated.

ARTICLES OF INCORPORATION OF
ARNT N. ANDERSON, INC.

KNOW ALL MEN BY THESE PRESENTS: That we whose names are hereby affixed, all of whom are bona-fide citizens of the United States, and two of whom are residents of the State of Idaho, have this day voluntarily associated ourselves together for the purposes of forming a Corporation under the laws of the State of Idaho. And we hereby certify in writing:

I.

The name of this Corporation is and shall be "Arnt N. Anderson, Inc."

II.

The objects and purposes for which this Corporation is formed are as follows:

To operate and carry on a general beer and cigar store in the City of Sandpoint, Idaho, and, without limiting the generality of the foregoing, to sell candies, tobaccos, drugs, fishing tackle and equipment, sportsmens merchandise, wearing apparel, soft drinks, to operate pool and billiard tables, card tables, and other amusement devises, to operate a restaurant, and to do any and all things consistant with the above objects.

To acquire and undertake the good will, property, rights, franchises and assets of every kind, and the liabilities of any person, firm, association or corporation, either wholly or partly, and pay for the same in cash, stock or bonds of the company or otherwise.

To acquire by gift, grant, purchase, devise, lease or otherwise both real and personal property necessary or convenient to the carrying out of the purposes of this corporation, and to hold, use, enjoy and dispose of the same in such manner as it may determine.

To sell, lease, mortgage, exchange, encumber, alienate, transfer, or convey, all or any of the real estate or personal property of this corporation, at such times and in such manner as it shall determine.

To borrow money for the carrying out of these purposes, and to issue and execute notes, mortgages, bonds or other evidence of indebtedness of the same in such form as it may deem advisable, and to secure the repayment of such indebtedness when and as it shall determine.

To make, enter into, perform and carry out contracts of any and every sort or kind, with any person, firm, association, or corporation consistent with these Articles of Incorporation.

To do all and everything necessary, convenient, suitable, or proper for the accomplishment for any of the purposes, or the attainment of all and any of the objects herein enumerated, or incidental of the powers herein named, or which at any time shall appear conducive or expedient for the protection or benefit of this corporation, or for the carrying out of its objects or purposes.

III.

That the place where the principal business of this corporation shall be transacted and its registered Post Office address shall be, Sandpoint, Bonner County, Idaho.

IV.

That the number of directors of said corporation shall be three.

V.

That the amount of capital stock of said corporation shall be \$10,000 divided into 100 shares of the par value of \$100 each.

VI.
