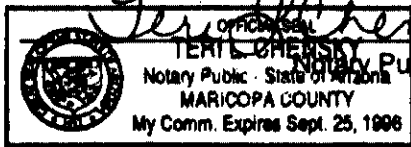
- The name of the corporation is SecurNet Financial Corporation. The name which it used in Idaho is same.
