ARTICLES OF INCORPORATION

ARTICLE 1. Name. The name of the corporation is Delorum Corporation.



ARTICLE 6. <u>Limitation on Personal Liability of Directors</u>. No director of the corporation shall be personally liable to the corporation or its shareholders for money damages for any action taken, or any failure to take any action, as a director, except liability for:

 - (ii) An intentional infliction of harm on the corporation or the shareholders,
 - (iii) A violation of section 30-1-833, Idaho Code, or
 - (iv) An intentional violation of criminal law.

ARTICLE 7. <u>Indemnification of Directors</u>. The corporation shall indemnify each and every director of the corporation for liability, as defined in section 30-1-850(5), Idaho Code, to any person for any action taken, or any failure to take any action, as a director, except liability for:

- (i) Receipt of a financial benefit to which he is not entitled,
- (ii) An intentional infliction of harm on the corporation or its shareholders,
- (iii) A violation of section 30-1-833, Idaho Code, or
- (iv) An intentional violation of criminal law.
