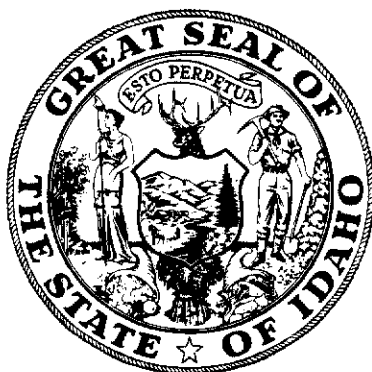


Section 8-C Ammended to read..."Officers shall serve for one (1) year after being installed at the June meeting after the elections."

Additions to the Articles as follows:


Section 13 Pretaining to the Tax Exempt Status of this organization:


- A. This corporation is organized exclusively for charitable purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code.
- B. Notwithstanding any other provision of thise articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c)(3) Of the Internal Revenue Code.
- C. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to an non-profit fund, foundation or corporation which has established its tax exempt status under Section 501 (c)(3) of the Internal Revenue Code.
