We, the undersigned, being natural persons of fulf age and citizens of the United States, in order to form a nonprefit corporation for the purposes stated below, under and pursuant to the provisions of the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code (the "Act"), and the acts amendatory thereof and supplemental thereto, hereby certify as follows:

- 1. Name: The name of the corporation is EASTERN IDAHO GROUND WATER USERS' ASSOCIATION, INC.
- 2. <u>Nonprofit Status</u>: The Corporation is a nonprofit corporation.
 - 3. <u>Duration</u>: The period of its duration is perpetual.
- 4. <u>Purposes:</u> The Corporation is organized and will be operated for these purposes:
 - A. To represent the interests of Eastern Idaho's ground water users and promote the efficient use and economic development of water resources.
 - B. To exercise all powers granted by law necessary and proper to carry out the above-stated purposes.
- 5. <u>Initial Registered Office and Agent</u>: The location and the physical address of the initial registered office of the corporation and its registered agent is as follows:

6. <u>Members:</u> The Corporation shall have such class or classes of members who shall have such rights as are provided in the Act and are consistent with the Bylaws and the management authority that these Articles grant the Board of Directors.

- 7. <u>Membership Dues</u>: Membership dues may be charged to all members in equal amounts or in different amounts or proportions upon different members and some members may be made exempt from such membership dues. The Board of Directors is authorized to fix the amount of membership dues from time to time, and to make them payable at such times or intervals, and upon such notice, and by such methods as the Board of Directors may prescribed.
- 8. <u>Directors</u>: The affairs of the Corporation shall be managed by its Board of Directors ("Board"), which shall consist of not less than three individuals, each of whom, at all times, shall be a member, or a duly authorized representative of a member, of the Corporation. The actual number of Directors may be fixed by the Bylaws of the Corporation or by vote from time to time of the Board. Other than the Directors constituting the initial Board, who are designated in these Articles, the Directors shall be elected or appointed by the members in the manner and for the term provided in the Bylaws of the Corporation.

11. <u>Distribution on Dissolution</u>: Upon dissolution of the Corporation, the Board shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all assets of the Corporation in a manner consistent with the Corporation's purposes.
