ARTICLES OF INCORPORATION

SEGRETARY OF STATE

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is RENAISSANCE DEVELOPMENT, INC.
