KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned officers of YOUTH ENDOWMENT FOR ACTIVITIES FOUNDATION, INC., an Idaho corporation, in order to amend the Articles of Incorporation of said corporation, do hereby certify as follows:

WHEREAS, the Articles of Incorporation of Youth Endowment for Activities Foundation, Inc. were adopted December 11, 1987; and

WHEREAS, the Corporation has no members other than the duly elected members of the Board of Directors; and

WHEREAS, the Board of Directors of the Corporation being Dr. Harris Allen, Rudy Ashenbrener, Dr. Richard Bauscher, Bill Campbell, Bob Donohue, Bob Dreyer, Myrna Johns, Dr. Roger Reynoldson, Senator Ann Rydalch, Bob Sobotta, Dr. Bill Stuart, Senator Bruce Sweeney and Bill Young, pursuant to Resolution of November 3, 1988, has unanimously adopted the following amendment to the Articles of Incorporation of Youth Endowment for Activities Foundation, Inc.:

That Article III - Purpose of the Articles of Incorporation of Youth Endowment for Activities Foundation, Inc. be amended

4 PURPOSE

5 This corporation is a nonprofit corporation organized under
6 the Idaho Nonprofit Corporation Act exclusively for educational
7 purposes within the meaning of Section 501(c)(3) of the
8 Internal Revenue Code of 1954 and its regulations as they now
9 exist or as they may hereafter be amended. The Corporation is
10 organized to provide financial support for state level
11 participation in association sponsored interscholastic
12 activities by all students of member schools of the Idaho High
13 School Activities Association, Inc. The Corporation is
14 organized and operated exclusively for the benefit of
15 nonprofit, private or public institutions of secondary
16 education located within the State of Idaho and all payments
17 for financial support for state level participation in Idaho
18 High School Activities Association sponsored activities shall
19 be made to such Idaho high schools.




