III.

PURPOSE

This corporation is a nonprofit corporation organized under 5 the Idaho Nonprofit Corporation Act exclusively for educational 6 purposes within the meaning of Section 501(c)(3) of the 7 Internal Revenue Code of 1954 and its regulations as they now 8 exist or as they may hereafter be amended. The Corporation is 9 organized to provide financial support for state level 10 participation in association sponsored interscholastic 11 activities by all students of member schools of the Idaho High 12 School Activities Association, Inc. The Corporation is 13 organized and operated exclusively for the benefit of 14 nonprofit, private or public institutions of secondary 15 education located within the State of Idaho and all payments 16 for financial support for state level participation in Idaho 17 High School Activities Association sponsored activities shall 18 be made to such Idaho high schools. 19
