The undersigned, residents of Idaho associates themselves into corporation under Idaho Code Title 30, Chapter 3.

ARTICLE I

The name of the corporation is Treasure Valley Comprehensive Referral Center, Inc.

ARTICLE II

The corporation is a nonprofit corporation.

ARTICLE III

The period of duration is perpetual.

ARTICLE IV

The purpose for which this corporation is formed is the transaction of any lawful business conferred upon nonprofit corporations and more specifically to furnish the area with a comprehensive centralized referral Center and to compile a comprehensive concise Referral Guide.

The corporation is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding sections of any future federal tax code.

ARTICLES OF INCORPORATION 1

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustee, officers or other private persons, except the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate of any public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or a corresponding section of any future federal tax code (b) by a corporation, contributions to which are deductible under Section 107 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE V

This corporation is not organized for profit and it shall not issue stock. Membership shall not entitle a person to any interest in the assets of the corporation but only to participate in the management of the corporation as provided in the bylaws. Its members shall consist of all

incorporators and all other natural persons elected to membership as provided in the Bylaws.

ARTICLE VI

The governing body shall consist of a Board of Directors.

ARTICLE VII
