## ARTICLES OF INCORPORATION

## SPECIALTY ELECTRICS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Arcticles of Incorporation for such corporation.

FIRST: The name of the corporation is SPECIALTY ELECTRICS, INC..

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized are for the engineering, design, supervision, construction, fabrication, sales and installation of electrical and electronic components, equipment, systems and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The corporation shall have authority to issue a total of 500 shares of capital stock of the par value of \$50.00 per share, all of which shares shall be of one class and shall be designated as common stock.
