AMENDMENT TO ARTICLES OF INCORPORATION OF ACME CENTER, INC.

BE IT KNOWN, That we, the undersigned, President and Secretary, respectively, of Acme Center, Inc., do hereby certify in accordance with the provisions of Section 30-146, Idaho Code, as follows:

- I. That a meeting of the shareholders of the issued and outstanding stock of Acme Center, Inc. was held at the office of the corporation at 711-1/2 Bannock Street, Bosse, Idaho, at 10:00 o'clock a.m., on the 1st day of October, 1962, pursuant to notice given more than thirty days prior to said meeting at which meeting all of the issued and outstanding common stock was represented in person on by proxy.
- 2. That at said meeting the following Resolution was unanimously adopted, to-wit:

"BE IT RESOLVED that Article First of the Articles of Incorporation of Acme Center, Inc. be amended by deleting the entire article, and inserting in place of it the following Article First:

ARTICLE FIRST. The name of the corporation is Highlands Center. Inc.
